Notice is hereby given that Gloucestershire County Council in exercise of its enabling powers under Section 84 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 proposes to make the above-named order the effect of which will be:

- 1) To prohibit the driving of any motor vehicle at a speed exceeding 40mph on the following roads in the Parish of Pitchcombe:
- A46 Cheltenham Road/Pitchcombe Junction to Wades Lane/Painswick Road From a point 22m south-west of its junction with Wades Lane (401215) to a point 160m south-west of its junction with Pincot Lane (401211)
- A4173 Gloucester Road From a point 236m north of its junction with Gloucester Road to Halfway Pitch (Lurks Lane) (401214) to its junction with A46 Cheltenham Road.
- 2) To reduce the extent of the existing 50mph speed limit to align with the new extent of 40mph speed limit.

The lengths of roads fall within the Parish of Pitchcombe within the Stroud District in the County of Gloucestershire.
